CALL TO ORDER: Meeting was called to order by Sherry Boschert at 4:07 PM.

ACCEPTANCE OF MINUTES

Greg Ames moved to accept the March 2022 minutes; Clifton Below seconded. The minutes were approved unanimously without change.

OLD BUSINESS

Clean School Bus Program

Tad passed on information from Jessica Wilcox on the application process for up to 100% of the cost of electric or alternative fuel school busses. The program determines 'priority' schools in each state and Lebanon is not listed as one. Tad will follow up with Meghan Butts.

Police Station EV Transition

Matt Isham and Mike Wright filled the Subcommittee in on EV vehicle and charging infrastructure development at the Police Station. The Station's parking lot was recently re-paved with Everett Hammond, Tad, and City Electrician Ted Makalinaw assisting the PD in planning and constructing the re-paving in light of future EV and additional solar infrastructure. There was then a robust discussion on various aspects relating to police cruiser transitions to EV's. The EFM and Greg Ames will work with the PD and DPW Garage to assess current electric loads on police cruisers in order to better plan for EV cruiser use and charging needs.

Multi-Town EV Infrastructure Cooperation

The EFM met with Hanover and Hartford recently and we are drafting a cooperative RFP for the development of public EV charging infrastructure. We are now looking for sample RFP's of this kind from other municipalities. The next meeting is July 27th at 10 PM.

Ford F-150

Greg Ames reported that the truck is being built "as we speak."

Communication with Planning Board, Developers

Sherry Boschert discussed recent conversations with staff at the Planning Office about how best to negotiate with project developers about EV charging infrastructure.

EV Subcommittee Outreach

Sherry Boschert discussed recent communications with City staff on how to increase outreach and exposure of the Subcommittee through City channels, including perhaps a dedicated webpage.

NEW BUSINESS

EV Charging Stations on Light Poles

Sherry Boschert discussed a new technology recently deployed in Seattle where Level 2 EV chargers are installed on streetlight poles with retractable cords. Clifton Below mentioned that this technology is also being deployed in Melrose, MA through National Grid. A *Clean Technica* article on this program/technology can be found [here](#).

GM Community Charging Program

Sherry Boschert mentioned that GM has a new program to make Level 2 EV chargers available within a certain distance of their dealers. The EFM Suggested that someone inform Rebecca Owens in the Planning Office about this program so that she can alert developers about this subsidized EV infrastructure.
