1. CALL TO ORDER – Chair Bromberg called the meeting to order at 3:39 PM

Chair Bromberg said that Mr. Doug Kogan, Clean Energy New Hampshire, is in attendance.

2. PREAMBLE – Read by Mr. Chris Kilmer

2. APPROVAL OF MINUTES:

A. April 23, 2026

3. OLD BUSINESS

A. Legislation 1 PUC Regulations, 1 CPCNH / LCP updates: CPCNH Publicity Campaign
Mr. Below shared the CPCNH Annual report with committee members, which was utilized during their
recent annual meeting in Concord.

The legislative session wrapped up with some victories. The battery enabling bill is on its way to the
Governor for approval. DOE ultimately got behind this bill as well, so he thinks it will be signed.

This bill allows one to have battery storage in conjunction with net metering. The commission can
address this in the future.

1
2 Another bill ready to be signed will allow towns to take funds through a specific type of trust account so
3 that the town does not have to go back every year to get funds appropriated because of not using all prior
4 appropriated funds.

5
6 A big bill which he has spoke about before would limit the ability of the commission to shift costs away
7 from default service and on to their cost recovery charge, like Eversource proposed a couple of years ago
8 before CPCNH helped to reveal the fact that under collections were not due to customer migration, but
9 rather due to internal errors by the company.

10
11 This ended up getting passed in the directionally correct way that says that the utility default service costs
12 should not be recovered, except from default service customers, except perhaps in extraordinary
13 circumstances, if the commission determines that in an adjudicated proceeding.

14
15 Liberty never proposed anything but to recover for default services closest to having perhaps an
16 extraordinary circumstance so they have asked to convene a meeting with the parties to their default
17 service case next Friday; Mr. Below will be attending this meeting.

18
19 Liberty's under recoveries are so large that they will be unresistant to try to recover them over the 12-
20 month period. They will be talking with other parties in the docket before they make a specific proposal.
21 Liberty continues to have under collections.

22
23 They got a data response from Eversource that indicates they lost over the course of December, January,
24 and February, under collections of approximately \$46 million. Some over-collections have helped offset
25 this amount down to a net under collections of more than \$26 million for this rate period. They are
26 forecasting over collections this month and the next two months, which may or may not be the case.

27
28 The commission's approach ** has disrupted the competitive markets, resulting in the perception that
29 CPCNH's rates are higher than utilities. He thinks that CPCNH will probably beat Liberty's rates , and
30 maybe for several years into the future. He anticipates that Eversource will appear to be less expensive
31 too, if they continue to underestimate their costs.

32
33 **The former Chair came up with a formula called the "proxy price formula", feeling like perhaps he
34 could outsmart a competitive market, even though there wasn't real evidence to substantiate the formula.

35
36 Mr. Below said they will be making efforts to educate the public by engaging their members to get the
37 messaging out, along with radio programs and other means.

38
39 B. Landfill Gas to Energy Project

40
41 Mr. Kilmer shared that the gas plant is currently running 3 micro turbines steadily. They just got their gas
42 report back and they are looking to change out the siloxane media again like the one they did in February.
43 The H2S media still seems to be working well, which could result in some cost savings since they have
44 gone from an estimated 5 weeks to three months between media changes. This is decreasing operational
45 cost considerably, given each media changes cost around \$60,000. They had projected nine media
46 changes per year, but this might well be reduced to only four . They will know more once they have a full
47 year of operation.

48

1 The chiller is problematic again so they are looking into some options. Currently it is stable and running
2 and generating power for the time being. Lastly, they are anticipating increased Liberty rates for at least
3 the next 1-2 years.

4
5 C. EV Subcommittee Report

6 a. Amending Site Plan Review Regulations

7 Several months ago, the City Council approved the zoning and instructed the Planning staff to pursue the
8 site plan review proposal for amendments. To date this has not happened.

9
10 Ms. Boschert heard from Mr. Nate Reichert, Director, Planning & Development, and suggested that they
11 get on the Planning Board's agenda with the goal to get this back on track. They should have a good idea
12 the beginning of June when they can get on the agenda, possibly as late as August due to their very heavy
13 schedule.

14
15 This will be LEAC's opportunity to raise this topic again with the Planning Board and inform them and
16 all their new members of the history of this and hopefully get them to consider and approve the
17 amendments that are needed for the site plan review process.

18
19 It was agreed that working with Planning staff should help them as they prepare for this meeting.

20
21 This impacts land developer John Levitus and Ms. Boschert will check in with him on this so that they
22 can communicate any updates.

23
24 Ms. Boschert has condensed the electric vehicle sections of the zoning ordinance and offered to share this
25 with LEAC members and in turn she asked for their input. Also, with Mr. Kogan's help, she updated the
26 white paper she had previously written and corrected some mathematical errors.

27
28 b. Recap of Earth Week

29 Ms. Boschert said the e-bike initiative is moving along. Mr. Stearns is continuing to talk to the City
30 building officials to ensure that they have all approvals and permits needed for this project.

31
32 She anticipates they will hear later this month about whether or not they got the T-Mobile Hometown
33 Grant to fund putting in two level 2 chargers in downtown Lebanon.

34
35 The Upper Valley Earth Week Open House has done their final report and this was another successful
36 event this year. They had a record number of sponsoring organizations, more people registered, more
37 attendees and also more advertising in the guide; consequently they were able to raise more money for the
38 e-bike project. Also, other communities joined in; for example Woodstock participated and had a big
39 turnout.

40
41 Ms. Boschert will be communicating with the organizers again soon, and they will decide if they will hold
42 this event annually or biennially. She is leaning towards biennially, because they also have the EV Expo
43 currently biennially, so alternating years on both of these could make sense.

44
45 D. Lebanon Energy Savings Program

46
47 Mr. Chaffee recently attended a webinar on the Heat Pump Accelerator Program and found it informative.
48 He was hoping that they could apply for a community level grant of \$100,000, but because of New

1 Hampshire's small population, there can only be one of these grants in NH, which makes it highly
2 competitive.

3
4 His goal is to get more rebate monies to help make heat pumps more affordable for landlords, but he's
5 also learned that rebates cannot be stacked with community grants. So he will continue to find out more
6 about their various options and he added that the criteria for these grants will be released sometime this
7 summer.

8
9 Ms. Boschert shared some information about the HEAR program, which Mr. Chaffee had discussed
10 during last month's meeting. Mr. Chaffee added that it is not yet clear when these rebates will become
11 available and reiterated that rebates cannot be stacked.

12
13 Mr. Rothe said that Mr. Chaffee has put together a half page handout, with the City seal, that he and Mr.
14 Chafee have been distributing and encouraging multi-family and single-family property owners to apply
15 for free energy audits.

16
17 Additionally, they will be attending the Farmer's Markets this year, talking with people and distributing
18 these ideally to multi-family property owners.

19
20 E. LEAC Priorities for 2026

21 a. New subcommittee: Energy efficiency in City Building

22 Chair Bromberg shared that he went on a tour of Lebanon Fire House #2 with Fire Chief Wheatley and
23 Mr. Jeff Hamilton, representative with Franklin Energy Management Consultants. He is checking to see if
24 they have any report he can view, to see what opportunities there might be.

25
26 Mr. Below spoke with Fire Chief Wheatley recently, and he is willing to give LEAC members a tour of
27 the new Lebanon Fire Station, which might take place as early as July or August, ideally in conjunction
28 with a LEAC meeting (ideal but not likely).

29
30 b. EV Subcommittee: pursue EV charger funding – see above – Ms. Boschert updated

31
32 c. Lebanon Energy Savings Subcommittee: publicize resources for energy savings and fossil
33 fuel reduction in the residential heating sector – see above - Mr. Chaffe & Mr. Rothe updated

34
35 d. C-PACER: Support City adoption: organize a conference to highlight C-PACER programs
36 with the area's largest commercial/industrial customers

37
38 Mr. Kogan said that the C-PACER program has amended their process so that towns can now
39 also use their Select Boards to adopt a picture district now, rather than having to wait for an
40 annual meeting. He said that lots of other companies will be joining Lebanon in the ranks of
41 C-based districts. He added that the City of Lebanon has done their work and now it is up to
42 developers to step up and apply for this program.

43
44 Ms. Boschert added that this is another topic she will speak with John Levitus about as he
45 was very interested in utilizing this C-Pacer program.

46

1 Chair Bromberg wants to be sure they let developers know about this program. He asked if
2 Hanover has adopted this program. They had in the past the but the necessary infrastructure
3 was not in place at the time.
4

- 5 e. Reduce streetlight levels – The City has access to the software and can adjust the lighting
6 level. Mr. Below and Mr. Kilmer will work on this and possibly also reach out to Mr. Paul
7 Coats with the City. Mr. Below said they will need to put this before the City Council and
8 that their new energy rates should be set in June, so sometime after that could be ideal.
9
- 10 f. Consider a local adder on the Lebanon Community Power bases rate – to be discussed again
11 at a future meeting

15 A. Brainstorm re: UV’s largest commercial/industrial energy users
16

17 Mr. Hamilton with Franklin Energy has said in last month’s meeting that he could get LEAC
18 a list of the biggest energy users in Lebanon, but Ms. Boschert subsequently learned from
19 him that he cannot legally share that database. So she then called Hanover and asked them
20 how they got this information; they had the same issue. Hanover simply took their best guess
21 and then called the various energy users.
22

23 To this end, Ms. Boschert prepared a list that she shared on the screen, composed of large
24 companies in Lebanon and West Lebanon. LEAC members went through this list in addition
25 to providing additional names of companies to contact.
26
